- * Reorders of less than \$50 are subject to a \$2.00 minimum order charge.
- * All Invoices are **due and payable** 30 days from the date of the invoice. After 45 days No future shipment will be made until the invoice with the **accumulated interest charges** are paid in full. A continued history of past due invoices will result in Shipment on a COD basis only.
- * Past due account are subject to a 1 ½% per month service charge.
- * All NSF and returns checks will be charged a \$25 handling fee.
- * Title to goods shipped passes to buyer upon delivery of goods to carrier.
- * All returns must have authorization from Muzzy Products and be shipped freight prepaid. Freight collect returns will not be accepted. **All returns are subject to a 15% restocking charge. Returns will not be accepted after 30 days from date of shipping.**
